

COOKIES POLICY

I. Cookie files

The entity that places cookies on the terminal equipment (e.g. computer, smartphone, tablet) of the User and obtains access to them is the operator of the website <https://www.qwed.com.pl/> (to be termed hereinafter as the "Website"), i.e. QWED Sp. z o.o. with headquarters in Warsaw - address: Krzywickiego 12 lok.1, 02-078 Warsaw, entered into the Register of Entrepreneurs kept by the District Court for the Capital City of Warsaw, XIV Commercial Division of the National Court Register under the KRS number: 0000132682, REGON: 012138440, NIP: 1132173057, the share capital of which is PLN 100,000.00 (to be termed hereinafter as the "QWED").

Cookie files (so-called "cookies") are computer data, in particular text files, which are stored on the User's terminal equipment, e.g. computer, smartphone, tablet and are designed for use with Website. Cookies allow the contained information to be read only by the server that created them, in this case the QWED server.

II. The purposes for which Cookies are used

Cookies are intended to collect data on the use of the Website by the User, and their main task is to facilitate the use of the Website.

Of the Website following types of cookies are to be used:

- a) "necessary" – those cookie files are used in response to actions undertaken by the User, such as: setting privacy options, logging in and filling out forms,
- b) "analytical" – those cookie files allow to measure quantity of Users' visits to the Website and to collect information about traffic sources as well as measuring the level of efficiency and performance of the Website, thanks to which we can improve the operation of the Website. What is more, they inform us which pages are the most popular on the Website and in what manner Users navigate the Website.

III. Types of Cookies

1. Detailed information about the cookies used by the Website can be found in the table below:

| Name | Expirytime | Description |

| cookiesAgree | 30 days from setup/update | Cookies save information about your consent to their processing. |
| _ga | 2 years from setup/update | This cookie is installed by Google Analytics. The cookie is used to calculate visitor, session, campaign data and keep track of site usage for the site's analytics report. The cookies store information anonymously and assign a randomly generated number to identify unique visitors. |
| _gid | 1 day from setup/update | This cookie is installed by Google Analytics. The cookie is used to store information of how visitors use a website and helps in creating an analytics report of how the website is doing. The data collected including the number visitors, the source where they have come from, and the pages visited in an anonymous form. |

2. Cookies do not store information that constitutes personal data of the User.
3. Cookies are not used by QWED to determine the User's identity.
4. The Website uses cookies with the consent of the User.
5. In many cases, the software used for browsing websites (web browsers) by default allows the storage cookies on the User's terminal equipment (e.g. computer, smartphone, tablet). The User may change the settings of the web browser regarding cookies at any time.
6. The web browser settings can be changed in particular in such a way as to block the automatic handling of cookies in the web browser settings or to inform the User about each placement of cookies on his or her terminal equipment (e.g. computer, smartphone, tablet).
7. The User may withdraw consent to saving cookies on his or her terminal equipment (e.g. computer, smartphone, tablet) at any time by disabling cookies - by following the instructions of the web browser he or she uses and deleting cookies from his browser.
8. In the event of withdrawal of the consent, cookie files may still save files on the terminal equipment but only those necessary to ensure the proper operation of the Website. The User may modify these settings within the web browser, but the restriction of the use of cookies may affect some of the functionality available on the Website- the Website might

be less efficient, the User may not have access to certain content, may not be able to use some of the Website's functionalities, and in extreme cases the correct display of the Website may be completely blocked.

9. Detailed information on the possibilities and methods of handling cookies by the web browser used by the User is available in the software (web browser) settings. Instructions on how to control cookies in popular browsers are provided below:

10. QWED uses Google Analytics with the aim of analyzing the usage of the Website pages. Goggle Analytics tool collects statistical data and other information about the method of using the Website, using cookies that are stored on the User's terminal equipment. The collected information related to the Website is used by QWED to create reports on use of the Website. Google will store and use those information for a period of 30 days up to 24 months, depending on the type of cookie file. Google privacy policy is available at: <https://policies.google.com/privacy>

After performing each update, the modified "Cookies Policy" will apply to Users and data provided by them from the date of updating the "Cookies Policy". QWED is to inform the Users about updating the "Cookies Policy" via the Website.
